

Rules of the “C1 Racing Club”

These Rules are made by the board of the RAW Motorsport Limited (the “Company”), in order to govern the membership of the C1 Racing Club (the “Club”)

1. NAME

The Club is called the C1 Racing Club

2. PURPOSE

The objects of the club are:

- 2.1. To attract members and collect membership fees, which are paid immediately to the Company to support its activities.
- 2.2. To encourage appropriate driving standards and conduct at Company events.

3. MANAGEMENT

The Company shall manage the Club in its entirety.

4. ADMISSION OF MEMBERS

- 4.1. Until a candidate for membership has paid the annual subscription he or she is not entitled to any of the privileges of the Club.
- 4.2. The board of the Company (the “Board”) shall determine the appropriate categories of membership and associated rights.
- 4.3. The Board reserves the right to remove a membership or refuse a membership application or renewal.

5. ELECTION

The Board, at its sole discretion, may elect candidates for membership.

6. ANNUAL SUBSCRIPTION

- 6.1. Every member must pay an annual subscription set by the Board.
- 6.2. The annual subscription of each member is deemed to be a debt due to the Club, payable to the Company which is authorised to receive the money on the Club’s behalf.

7. EXPULSION OF MEMBERS

The Board may expel any member who offends against the rules of the Club or whose conduct, in the opinion of the Board, renders him or her unfit for membership of the Club.

8. BANKING

All monies of the Club shall be remitted immediately to the Company to support its activities.

9. MODIFICATION OF RULES

- 9.1. These rules may only be modified by the Board.
- 9.2. As soon as possible and in any case within 28 days after the making of any alteration or addition to these rules the Board must give notice of the alteration or addition on the C1 Racing Club website.

10. CODE OF CONDUCT

The C1 Racing Club is fully committed to safeguarding and promoting the well-being of all its members, ensuring a positive and enjoyable experience for all. The Club believes that it is important that members, administrators and parents associated with the Club should, at all times, show respect and understanding for the safety and welfare of others. Therefore, members are encouraged to be open at all times and to share any concerns or complaints that they may have about any aspect of the Club with Robin Welsh, Chairman.

As a member of the Club, you agree to abide by the following code of conduct:

- 10.1. All members must take responsibility in ensuring they are up to date with the rules, understand and adhere to them.
- 10.2. All members must respect the rights, dignity and worth of all participants regardless of age, gender, ability, race, cultural background, religious beliefs or sexual identity.
- 10.3. Members should recognise the valuable contribution made by officials who are usually volunteers. They give their time and resources to provide motor racing for you.
- 10.4. All members must respect officials and publicly accept their decisions.
- 10.5. All members should be a positive role model, treat other competitors and officials with the same level of respect you would expect to be shown to you.
- 10.6. Members must not harass or intimidate by words, gestures, body language, or any type of menacing behaviour any other person.
- 10.7. Members must not have physical contact with another person in an angry, aggressive, or threatening way either on-track or off-track.
- 10.8. Verbally abusive behaviour, including profanity, angry language, swearing, name-calling, or shouting either on-track or off-track will not be tolerated.
- 10.9. Bullying of any sort either on-track or off-track will not be tolerated. Encourage everyone to enjoy the sport and understand that people have different motivations for taking part.
- 10.10. If a member's behaviour, whether physical, verbal or by any other means of communication, has the effect of bringing the Club or motorsport into disrepute, the Club reserves the right to remove that person's membership.

11. DRUGS & ALCOHOL

Consumption of alcohol or other intoxicating drugs is incompatible with motorsport. The Club has a zero-tolerance policy to the consumption of such drugs in any way that would affect team members driving or controlling the car.

- 11.1. Any team member that drives, works on, or controls the car in the pits / pit lane ("Team Members") is required to maintain a Zero Alcohol Level at all times during the Meeting.
- 11.2. All Team Members are subject to breathalyser testing at any point during or up to two hours prior to signing on, testing, warm up, qualifying or racing ("On-track Sessions"). The sole approved breathalysers used for testing will be AlcoVisor Mercury breathalysers within valid calibration periods of their current calibration certificates. Calibration and maintenance of the devices will be undertaken by Breathalyser Direct Ltd.

- 11.3. Team Members must declare and show proof in writing of any medical condition and/or medications that could compromise the test or result in a false-positive reading to the Club at least 48 hours before the start of the meeting.
- 11.4. If a Team Member fails a breathalyser test, their Team will be immediately excluded from the Meeting.
- 11.5. A Team Member may also confidentially request a breathalyser test be carried out on any other Team Member at any time during the On-track Sessions should they have substantive belief that the Team Member may be over the Zero Alcohol Level. This request must be made in writing to the Club, who will not refuse such first request.
- 11.6. There is no appeal or recourse on the failure of the breathalyser test, beyond requesting that a re-test be immediately taken utilising another approved device.
- 11.7. Refusal or withdrawal of consent to take a breathalyser test will be treated as a failure of the test and the Team shall be excluded from participation at the meeting.
- 11.8. If a Team Member is suspected of being under the influence of other intoxicating drugs, he or she will be reported to the Clerk of the Course.

12. MEMBERSHIP POINTS

The Club operates a points system for Members. The board can apply points to a Member for driving standards, alcohol or drug abuse, behaviour which may affect the Club's reputation or for any other reason.

- 12.1. Points remain on a Member's record for 2 years from the date of application
- 12.2. If a Member reaches 12 points, his or her membership will be withdrawn.

13. HEADINGS

The headings to these rules are for ease of reference only and are not to be considered in their interpretation.
